Abstract:	Board member, Andy Swarbrick leads the Theatre's audit committee. He describes the role of a board member, reflects on the Theatre's successful Foyer Project (2013) and looks forward to a future project undertaking essential improvement works to the Theatre's auditorium.

00.00	Swarbrick moved to Cambridge in 1975 after university. He came to the theatre often and in 2011 he was asked by Dave Murphy to come onto the board, to offer financial knowledge, and has been a member for 9 years.
01.22	He says that the theatre has become more professional. Swarbrick says that the theatre is historically a receiving house, and other than the pantomime didn't do any of their own productions. He notes that in the last couple years the theatre has tried to do its own productions, which have been successful. Swarbrick hopes in the future more will be done, because the stock of productions from elsewhere is limited. He says that the theatre is often unable to fill certain weeks, and having their own productions gives them greater flexibility.
02.33	Swarbrick recalls seeing Shakespeare at the Arts, as well as <i>The Winslow Boy</i> and <i>An Inspector Calls</i> . He notes his passion is Opera, which is put on a couple times a year. Swarbrick recalls attending the Greek play a couple times, which he thinks is entrepreneurial for the theatre to put on. He says the most memorable show he has seen was <i>Mary, Queen of Scots</i> . Swarbrick commends Dave Murphy for encouraging west end shows to come to the theatre, which has been happening for the last 10yrs.
03.40	He describes the variety of people who sit on the board. Swarbrick believes it is a strong board.
04.15	Swarbrick recalls the refurbishment 25yrs ago and describes it as lifesaving for the theatre. He says the project on the foyer was excellent, as before that it was too cramped and put people off from using the bars. He says they are much more accessible now. Swarbrick recalls the board discussing the restaurant on the 4 th floor, which fell out of use as there are lots of restaurants in Cambridge. He believes the foyer project was a great success.
05.41	He notes that the operatic touring company has an obscure repertoire, which sometimes annoys him as it puts people off. Swarbrick recalls that the operas sell well as there is an audience for them in Cambridge. He brings his grandchildren to the pantomime, and often goes to the gala nights also. Swarbrick says that it has created a reputation for itself and has grown year on year. He notes it appeals to all ages and has become a Cambridge Institution.
07.21	He described the 2020 pantomime <i>Cinderella</i> and the Theatre's purchase of a pantomime horse. His work on expanding the Theatre's corporate partners including, Oliver Dixon [Dixon Phillips LLP], Carter Jonas. The importance of a diverse programme for attracting a broad audience.
11.52	Swarbrick complements the Theatre staff on their passion and commitment.
13.00	He describes the commitment required of a board member and the nature of the role, meetings and away days, committee meetings, agendas. He complements the quality of the board
